

# Healthy Acadia's Blueberry 5 Mile Run/Walk & 1 Mile Fun Run/Walk

**When:** Saturday **August 18, 2018**, 1 mile & 5 miles. Registration begins at 6:00 a.m. Race begins at 8:00 a.m. SHARP; Rain or Shine.

**Where:** Machias Valley Baptist Church, Hemmingway Annex (the old Machias Town Office), 118 Court Street, Machias, Maine

**Course:** 5 Mile; scenic, hilly loop course

**Entry:** 5 Mile: **\$25.00 per-registration** (non-refundable), **\$30.00 day of the race**,  
1 Mile **\$10.00 per-registration** (non-refundable), **\$15.00 day of the race**

**Pre-register by July 27, 2018 to reserve your T-shirt size!**

**Race Features:** Kick-off to the annual Machias Wild Blueberry Festival, which features craft vendors, exhibits, and food. Healthy Acadia has partnered with Brian Hubbell's Timing System, a professional race management company based in Bar Harbor. Hubbell is coordinating the electronic timing system. Mile splits at 1 and 3. Water stations at mile 2, 4 and finish. A fast downhill finish with many cheering spectators!

**Awards for 5 Mile:** Top 3 female & male overall. Top female & male ages: 14 & under, 15-24, 25-40, 41-55, 56-70, & 71 & older. Also 1<sup>st</sup> Walker.

**Team Awards:** 1<sup>st</sup> & 2<sup>nd</sup> teams. **Teams MUST pre-register by 4pm on August 15th.** Unlimited number may register. Top 3 score by place of finish. Ties are determined by fastest cumulative times.

**Awards for 1 Mile:** Top female & male ages: 8 & under, 9-10, & 11-13
